Before kosher transport there will be a special cleaning comprising the standard cleaning, followed by 30 minutes steam, conforming to the rules of the rabbinate, the NRTCA and EFTCO. The exception to this is if the transport company has its own kosher certificate. Than the kosher certificate must specify the trailer and/or container and order number, the last three previous cargoes, the kosher transport and the date container was cleaned

This kosher certificate is signed on 3 January 2025 and valid until 1 February 2026.
